COURSE DESCRIPTION

This course will explore the role of governments in the economy and answer questions such as how does the government affect the economy? What is the appropriate role and size of government? Should the government do more, or less? In specific, we will talk about the government budget, government regulations (concerning the environment and public health), and government programs (such as education, health care, social security and welfare). We will also talk about voting rules and how governments make decisions. Methodologically, we will study these topics using both economic theory and data analysis.

COURSE MATERIALS

- **Lecture notes:** I will post lecture notes and articles on a weekly basis on Moodle under Lectures. I suggest you to print the notes and bring them to class. There is no need to print the articles unless I specify otherwise.

• Final Exam

• In-class participation

Participation will be assessed based on attendance and contributions to in-class activities such as discussions, group activities, active review sessions. After each class, I will record your participation mark as follows: absent (0), present but non contributing (1), present and contributing (2). On days when there is no in-class activity, students who are present will receive a score of 2. At the end of the semester, your participation grade will be calculated as follows. I will drop your lowest 3 marks and add your remaining participation marks, which will then be transformed into a percentage score.
